## 1. Remarks/*Remarques*:

- a. The Presiding Judge noted that the proceedings had been delayed due to the late arrival of the witness.
- b. Defence Witness JMR1 (DW11) entered the courtroom and made the solemn declaration.
- c. The Defence (Mr. Altit) examined Defence Witness JMR1 from 8:59 to 9:36 a.m. in closed session and then until 12:40 p.m. in open session with an adjournment from 10:43 to 11:07 a.m.
- d. The Prosecution (Mr. Ismail) cross-examined Defence Witness JMR1 from 12:40 to 3:45 p.m. in open session with an adjournment from 1:04 to 3:04 p.m. The Defence (Mr. Altit) did not re-examine the witness. The Bench questioned Witness JMR1 and then his testimony was concluded. His request to meet with the Accused was referred to the Registry (WVSS) for arrangement.
- e. The parties discussed the sequence of the upcoming Defence witnesses. The Defence (Mr. Altit) informed the Chamber that two of his witnesses, GMC4 and MMU6, who were expected to have arrived in Arusha, were not there yet. The parties agreed to discuss between themselves about the sequence of witnesses for the week to come and to inform the Chamber accordingly. In the absence of further Defence witnesses, the proceedings were adjourned until a date to be later indicated.
